Photographic reproduction services are provided by the Maryknoll Mission Archives as an aid to researchers. Until such time that permission to publish has been approved by the Maryknoll Mission Archives, photographic reproductions are made solely for the personal use of the individual researcher. They may not be reproduced, transferred to another individual or organization, nor may they be loaned or deposited in another library, archives, etc., without the prior permission of the Maryknoll Mission Archives. Duplication in no way transfers either copyright or property rights, nor does it constitute permission to publish in excess of "fair use" or to display materials. Separate written permission is required to publish, reproduce or display any image.

In addition:

The Maryknoll Mission Archives reserves the right to refuse to reproduce certain materials.

The Maryknoll Mission Archives retains the right to ask for the return of images when the user has completed a research project.

Archives staff handles all arrangements for photographic reproduction.

Fees:

See fee schedule. If the photographic reproductions are to be mailed, the researcher must pay the cost of postage. Payment must be received before images are released. Make checks payable to "Maryknoll Mission Archives."

To request photographic reproductions:

- 1. Read this form carefully and sign below.
- 2. Identify each image to be reproduced using the method described by a member of the Archives staff. Do not remove any items from their folders. Do not rearrange materials in the folder. Always wear white gloves when handling visual media.
- 3. List each item to be reproduced on the back of this form. Include all requested information. Use as many forms as necessary. Please sign each form.
- 4. Give the order to a member of the Archives staff. Orders will be filled as staff time permits.
- 5. Indicate if you will pick up the copies or if they should be mailed. Payment can be made when the order is completed, by either cash or a check made payable to "Maryknoll Mission Archives."

NOTICE: WARNING CONCERNING COPYRIGHT RESTRICTIONS

The copyright law of the United States (Title 17, U.S. Code) governs the making of photocopies or other reproductions of copyrighted material.

Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction. One of these conditions is that the photocopy or reproduction is not to be used for any purpose other than private study, scholarship, or research.
